1.1 What is the Family and Children’s Trust Fund of Virginia (FACT)?

Beginning in the early 1970s, child maltreatment prevention efforts began to gain momentum across the country. While there was new and exciting energy underway, it was difficult for states to set aside funds that specifically focused on the prevention of child abuse and neglect. When budgets were strapped, key leaders oftentimes targeted prevention funds rather than cutting treatment services. As a result, as early as the 1980s, states began establishing children’s trust funds as a way to ensure funds for prevention would be available to local communities. In Virginia, key leaders decided to establish a trust fund for both children and families. Thus, the Family and Children’s Trust Fund was established in 1986.

FACT is governed by a Board of Trustees, appointed by the Governor, to raise and distribute funds for family violence prevention and treatment efforts, as well as promote public awareness of family violence issues across the Commonwealth. One tool for raising public awareness has been through the creation of the FACT Report.

1.2 What is the FACT Report?

The FACT Report was first published in 2010 as a compilation of family violence indicators across the lifespan. It includes data on children, families and older adults. The FACT Report was created with these primary objectives in mind:

- ➔ to establish a single location for data, presented in a usable and easy to understand format, concerning family violence prevention and intervention;
- ➔ to provide data that can be used by policymakers to shape policy and resource decisions; and
- ➔ to raise awareness about the need for more standardized data surrounding family violence across the lifespan continuum.

Since the first report was published in 2010, it has evolved and changed through the guidance of an expert panel of professionals who sit on FACT's Editorial and Planning Committee, as well as through the leadership of FACT's Board of Trustees and Executive Director. It is now comprised of three report components: *Violence at Home: The FACT Report*, *The FACT Report Roamap*, and *Family Violence Indicator Data Guide*. Locality-specific data and accompanying data charts and maps are now found online through FACT's online data portal.

2.1 How Do I Use This Report?

Having family violence data compiled and available in one central, accessible and easy-to-use format is critical in order to:

- ➔ raise community awareness and generate discussions about family violence;
- ➔ identify and monitor family violence trends over time;
- ➔ set benchmarks and develop strategies to target specific family violence indicators;
- ➔ identify "best practice" resources and encourage collaborative efforts to address family violence across service sectors; and
- ➔ develop action plans to most effectively address family violence in the Commonwealth of Virginia.

Visual instructions for how to generate reports and utilize the features found in the data tool are detailed in the following section. This information can be used in a variety of ways and can be downloaded for further analysis, shared online or by email, or used to apply for funding to address issues at a community level.

2.2 How Do I Generate an Online Report?

To generate a local data report, select an indicator by title at one of the links below.

Family Violence Indicator Local Data Tool

Using the Family Violence Indicator Local Data Tool, you can build custom, downloadable reports for indicators of family violence, including:

- Line graphs showing trend data for selected localities;
- Custom data tables sorted and color coded by rate;
- Shaded maps for the year selected with the ability to view data geographically.





Notes:

This indicator counts founded investigations, not the number of children abused/neglected. Children may be counted more than once if an investigation identifies more than one type of abuse/neglect or if multiple investigations throughout the year are founded. This indicator counts substantiated reports, not persons abused. Certain local agencies serve multiple counties. For example, the same rate will be displayed for York and Poquoson as the information for these combined localities can be difficult to accurately disaggregate. A full list of combined localities can be found in the Data Guide.


Upon validating a report of child abuse or neglect for an investigation response, a local department of social services determines whether the investigation is founded based on a preponderance of evidence showing that maltreatment has occurred. Types of child abuse and neglect for which an investigation may be founded include physical abuse, physical neglect, sexual abuse, mental abuse/neglect, and medical neglect. A large number of valid reports of child abuse and neglect receive a family assessment response rather than an investigation; assessments are not included in these data. Family assessments are the preferred response when a child is not in immediate danger and include developing plans to remedy and/or prevent risk of future abuse. Investigations are conducted when there are immediate concerns about child safety, a prior history of child abuse, and/or the reported allegation is severe. This indicator reflects the number of founded investigations for any type of child abuse/neglect, not the number of children abused/neglected; children may be counted more than once if they experience more than one type of












Use the mouse to highlight and display data for a specific county. By selecting “keep only” you can create a graphic display for that county alone.



When clicking on the download arrow, a box will appear. This allows the user to download the dashboard as an image, data, crosstab or PDF. The image or PDF options are best if trying to embed this into a presentation or document. Data or crosstab are assist in doing independent analysis in Excel.

The share option is simplest when sharing through social media. In addition, an email or link can be generated for a web view of the dashboard in Tableau.

3.1 What are the Family Violence Indicators?

Indicators are measures of a social condition or behavior. They are typically used to describe a problem being targeted, such as family violence, and identify dimensions of the problem. Once measured, it is possible to set benchmarks and compare the state of the problem over time. These family violence indicators are not intended to imply causation. Instead, they are research based correlates or proxies that help to communicate the scope and response to the issue of family violence in the community.

Indicators used in the FACT Report are grounded in findings from studies conducted by both George Mason University and Virginia Commonwealth University. They identified indicators and risk factors of family violence based on a review of research literature and surveys of family violence workers. With assistance from Communitas Consulting, a consultant group tasked with drafting the FACT Report, indicators were narrowed down after statewide outreach and discussions took place with stakeholders. Adapted from the Fiscal Policy Studies Institute's "Results-Based-Accountability" model, indicators of the scope of family violence meet the following criteria:

- Communication – Does this indicator clearly convey to the public an increased understanding of the state of family violence?
- Proxy value – Is this indicator an effective stand-in for communicating family violence?
- Measurability – Is this indicator quantifiable on an annualized basis?

In addition to indicators that capture the scope of the problem, the report includes community context and response indicators. These were required to meet slightly different criteria for inclusion:

- Communication – Does this indicator clearly convey to the public an increased understanding of the state of family violence?
- Correlation with family violence – Does the indicator have documented evidence for correlation with family violence or response to family violence?

Indicators that met these first two criteria were then included if they met the following criteria:

- Accessibility – Is this indicator readily accessible and tracked in every locality in the Commonwealth of Virginia?
- Reliability – Do all localities report this indicator in the same way, and does it accurately reflect what it says it does?
- Validity – Are the numbers accurate and tested consistently?

Some indicators that were eliminated at this initial stage have since been included as data has become available or as data collection methods have improved in quality. Indicators are continually assessed to determine whether these criteria can still be met or to determine if new data should be included.

Beginning in 2013, FACT staff chose to use VAdata as the data source for domestic violence programs.
