#### Meeting called to order by Ginny Powell at 2:05 PM

A quorum was present. All motions were passed unanimously unless otherwise noted.

#### TANF Funding Update, Laurel Aparicio

- Laurel provided an update on the home visiting financial crisis. An overview of her presentation can be found here.
- There was discussion around multiple family and children funding sources experiencing cuts such as childcare, the end of American Rescue Plan Act (ARPA) funds, and major cuts to VOCA.
- There was a motion for the CAN Committee to submit a letter of support to the Governor for general funds to replace the loss in TANF funding for home visiting.

#### Updates from the Office of the Children's Ombudsman (OCO), Eric Reynolds

- Annual report will be published soon. Some preliminary findings are below:
  - 165% increase in reports made this is expected as the public gains more awareness of the office
  - 446 complaints total 77% moved forward to the investigation stage.
  - Common issues identified were inadequate services (lack of visits, workers not attentive to child or parents, lack of internal or external communication, etc.), documentation (lack of detail or documentation at all), foster parent expectations, improper screening out of CPS reports by local departments, issues with CPS investigation procedure, and placement decisions.
  - Received 50 notifications of child fatalities that were suspected of abuse/neglect and the family had prior involvement with CPS. This is up from 31 cases reported last year.
    - Substance-exposed infants (typically 3-5 months old) and parental substance use were common themes in the fatalities.

#### FACT Updates, Nicole Poulin

- The latest issue brief on <u>People with Disabilities</u> has been published. This is part of a new series on Special Populations.
- <u>Problematic Sexual Behavior Project</u> recommendations were made previously during Phase I and the Board has approved for Phase II to pilot the recommendations in a few localities. The funding request for the project is currently working its way through procurement.
- Currently working on a letter to support budget amendments to increase funding for the VDSS workforce.

## Review of VDSS's Office of Trauma and Resilience Policy Workforce Development Activities, Laurie Crawford

- Data findings from the 20 workforce focus groups will be released in mid-December. A preview of the finding can be found here.
- A quantitative survey to supplement the focus group data will be sent out in January. These data findings will hopefully be available at the end of January.

#### **VDSS Family Services Workforce Update**, Nikole Cox

- Virginia currently has a 15% vacancy rate for family services staff.
- Funding for additional positions was not approved during the 2023 General Assembly session.
- Some identified areas for improvement: resources for developing a central training academy model; increasing recruitment of staff through expansion of the college stipend program; implementation of a peer support helpline for workers to process cases with an experienced worker.
- VDSS CRP & CAPTA Update, Tammika Fedrick & Craig Patterson
  - Working with the Capacity Building Center for States for peer-to-peer support. Meeting with different states to gather information about their Citizen Review Panels (CRP)
  - The OCO has expressed interest in managing the Virginia CRP as it is restructured.
  - Craig provided an update on VDSS Family Services Prevention Interventions. The <u>slides can be found</u> here.
