### Approval of Minutes, Season Roberts

### Updates from the Office of the Children's Ombudsman (OCO), Eric Reynolds

- The annual report will be published by October 1st.
  - Recommendations will include improvements in the workforce, bolstering Child Protective Services responses especially for the youngest children, increasing state-level oversight, improving legal representation, and establishing a children's cabinet.
- There was discussion around cannabis use continually coming up in child fatality cases and potential responses and educational opportunities.
  - Members discussed the potential to send an advisory letter drawing attention to the issue once the OCO report has been released and additional research has been done.

### FACT Updates, Nicole Poulin & Taylor Hohle

 Problematic Sexual Behavior Project – the train-the-trainer curriculum on how to respond to these cases is being developed and will be piloted with select Multi-Disciplinary Teams (MDTs) in early 2026.

- Child Sexual Abuse Prevention Plan nine Child Advocacy Centers have been awards \$10,000 to support prevention efforts in line with the state plan that was released earlier this year.

  - Child fatality review workgroup The workgroup has been reviewing select child fatality cases from Fiscal Year 2023 across the five Virginia Department of Social Services (VDSS) regions. Reviews will be finished later this month and a final report will be published with themes and findings.

# VDSS Updates and Discussion on Issues Outlined in the 2025 CAN CAPTA Report, Nikki Cox, Division of Family Services

- Safe Kids, Strong Families Updates
  - The Safe Kids, Strong Families initiative has included working with a contractor to review the current child welfare system and provide recommendations for improvements. The contractors finished their recommendations last week. The initiative's steering committee has made some suggestions and priorities around six pillars:
    - Strengthening workforce VDSS would take a more active role in the recruitment pipeline to assist and support local agencies. Establishing competitive compensation for Family Services Specialists to reduce turnover.
    - Child Protective Services The creation of a centralized intake and validity system to assist in unified screening decisions. Updating the current response time guidance to include children under 3 years old requiring a response within 24 hours. Currently this is only for children under 2 years old.
    - Modernization of oversight and infrastructure The contractors reviewed the right other states that operate a state-supervised, locally-administered system like Virginia. Recommendations will include introducing a statewide accountability framework through legislation. Additionally, much-needed updates to data systems, including Oasis. The Request for Proposals to update Oasis will hopefully be out by the end of the year.
    - Permanency of youth Working to reduce congregate care for high acuity youth and finding safe and appropriate placements.
    - Behavioral health and child welfare –Ensuring that children in foster care are

receiving proper services and an additional focus on substance use in parents.

 Community pathways – Expanding prevention services in each locality and finding additional ways to bring in more federal Title IV-E funding for these services.

### Update from the Office of Trauma and Resilience Policy (OTRP) at VDSS. Laurie Crawford

- OTRP is working on the Strengthening the Workforce pillar of Safe Kids, Strong Families to include previous proposals around a peer support line for workers, critical incidence response, and community resilience training.
- Cost of Family Services turnover report has been published: <a href="https://www.dss.virginia.gov/files/division/otrp/intro">https://www.dss.virginia.gov/files/division/otrp/intro</a> page/workforce trauma/Cost of Child Welfare Turnover Report.pdf
  - 40% of entry-level Family Services Specialists (FSS 1) leave their jobs annually. The average tenure is eleven months.
  - \$11.1 million/year is spent on salary and benefits for FFS 1 employees who leave within oneyear. An additional \$717,000/year is spent on required training for FFS 1 staff alone. In comparison, the OTRP proposal would cost around \$600,000/year.
- The Virginia Helping Everyone Access Linked Systems (HEALS) Website has been updated to share resources, toolkits, and training – <a href="https://virginiaheals.com/">https://virginiaheals.com/</a>
- Partnering with Local Training and Development to provide one session a month of the Community
  Resilience Model for local DSS employees. Sessions filled up very quickly with a large waitlist showing
  a heavy interest in the topic/training within the local workforce.
  - Local Training and Development will be invited to the next meeting to discuss updates on the training academy.
